Further, this Contract shall include any future addendums and modifications.

Subcontractor is to furnish labor and materials necessary to perform the work described in its bid/proposal to Contractor in accordance with but not limited to the above-referenced documents. Subcontractor shall be responsible for conditions or circumstances as they exist at the time of signing of this Subcontract Agreement.

General Statement of work to be performed:

SUBCONTRACTOR SHALL PERFORM THE TYPE OF WORK DESCRIBED HEREIN AND EVERTHING NECESSARY TO COMPLETE THE WORK IN COMPLIANCE WITH ANY APPLICABLE LAWS AND BUILDING CODES, TO OBTAIN ANY INSPECTIONS APPROVALS AND TO INSURE EVERYTHING IS IN GOOD WORKING ORDER, AND SUBCONTRACTOR SHALL ALSO PROVIDE ALL LABOR AND MATERIAL REQUIRED AND FURNISH AND PAY FOR ALL LAYOUT, GRADE SETTING, TESTING, SCAFFOLDING AND

PLANKING, HOISTING, BACKING, TEMPORY HEAT, POWER AND LIGHTS, BONDING INSURANCE, LICENSES, PERMITS, COSTS AND FEES REQUIRED FOR WORK TO BE PERFORMED UNDER THIS SUBCONTRACT, UNLESS OTHERWISE STATED IN THIS SUBCONTRACT.
